## It is the serious, existential threat of the massive demolition of our community by the Hyde property company

Hyde is currently aggressively hustling a scheme to demolish multiple homes across a 3-acre area

Not only would this directly affect the large number of residents whose homes would be destroyed.

But it would also indirectly impact thousands of local residents in the surrounding area – who would be adversely affected for years by the disruption, noise, dirt, traffic, parking restrictions etc etc caused by the demolitions and the construction of massive unsightly for-profit high-rise tower blocks.

(With a few token "social housing" units included – just a sufficient number to enable Hyde to extract a fat grant from the Greater London Authority so that we tax-payers will subsidize Hyde building nearly 500 for-profit housing units for them to sell)

Knowing that there is quite understandably a proclivity by local authorities to support the building of new homes in London - Hyde is cynically hiding behind that genuine need as a device to pressure acceptance of its scheme to bulldoze many homes.

Including some architecturally-acclaimed historic Victorian buildings.

But the net result of Hyde's scheme to demolish our homes in order to line their pockets is that they would also be bulldozing our long-established community.

We can either surrender to Hyde's high-pressure tactics in its pursuit of profits

Or we can join together to protect our community.
